LATEX DRYWALL & FOAMBOARD ADHESIVE

TECHNICAL DATA SHEET

PRODUCT DESCRIPTION:

Miracle® DSA40 is used for installing regular and vinyl-faced gypsum wallboard to wood or galvanized framing members. Also bonds insulation foam board to concrete, concrete block and wood. Must have at least one porous surface.

^{*} The shelf life for an unopened container of this adhesive stored at temperatures between 60°F (15.6°C) and 95°F (35°C) is 1 year from date of manufacture. Store out of direct sunlight in a cool, well-ventilated area. Avoid storing container directly on the floor or against an outside wall

DIRECTIONS FOR USE:

- Use only after careful consideration of the warnings, directions, and first aid instructions given.
- Apply a 3/8" bead to clean framing members with hand caulking gun.
- Where two boards butt on a framing member apply zig-zag bead so adhesive will contact both boards.
- Do not apply adhesive more than 30 minutes before installing drywall.

- Store at room temperature.
- Before using, store adhesive at temperatures of between 70°F to 80°F (21°C to 26°C) for 24 hours.
- Do not apply at temperatures below 40°F.
- Do not permit installation to go below freezing for a minimum of 24 hours after application.
- Must have at least one porous surface.
- Not for use with FRP panels.
- DO NOT THIN.

WALLS

- Place board on framing and press firmly into place.
- Use fasteners 16" on center around perimeter of hoard
- No fasteners required in the field of the board.

CEILINGS

- Application is the same as for walls except use fasteners 24" on center in the field of the board when hung parallel to framing.
- Use only one fastener in the center of the board per framing member when hung perpendicular to framing.
- To install insulation foamboard apply 3/8" bead of DSA40 to face of board 3" from edge.
- Space vertical beads 8" to 10" apart.
- Press board firmly into place.
- To install gypsum board over foamboard, apply adhesive in the same manner.
- Nail 16" on center at top and bottom.

CLEAN UP:

When dry, mineral spirits may be used, exercising safe practices.
